EMIR Data collection – so far :



Huge number of questionnaires which are a heavy burden for the NFCs as well as for the FCs asking for the information, all the more so since format of these requests are not harmonized.

Once the information is collected, there is no guarantee that a change in a key-information, such as a NFC becoming a NFC+, is known in a timely manner by its FCs. Beside this key data, any other change of operational information should be brought to its counterparties' knowledge, either.

Don't wait until you are notified. Just participate to sharing of information. And be informed on a real time basis about changes affecting others.

A major improvement in the management of Third – party databases :

Beyond the sole purpose of the implementation of EMIR regulation, any third party database :

- relies on collection of data on a bilateral basis

whereas information can be made available and shared spontaneously by your contracting parties which incidentally save a lot of time to both parties ;

- and assumes that your contracting parties do think about informing you when something happens to them that has an impact on your contractual relationship

whereas cross monitoring [®] enables you to be immediately aware of changes without requiring your contracting party to notify

(We almost forgot another key feature of NotiFide) :
