Special Conditions

Section 1 – Rates

1- Subscription for a single legal vehicle

As consideration for the subscription to the <u>www.NotiFide.com</u> web-site, the yearly remuneration to be paid as mentioned under Section 13 of the General Conditions shall be equal to:

- EUR 3.000 (+ tax), for entities having 500 employees or more, or

- EUR 1.000 (+ tax), for entities having less than 500 employees.

The Client-User undertakes to provide justification of its staff number as it appears in its last annual report, upon request of NotiFide.

2- Subscription for multiple legal vehicles belonging to the same Group

For the purposes of the special rate described below Group shall be defined as a group of affiliated companies linked to a single Administrator (as defined in the General Conditions). Upon request of NotiFide the Administrator must be able to demonstrate that the entities in his Group are held directly or indirectly by a single entity or are united by community of interests (e.g. asset management companies – such as funds, SICAVs and Investment management companies - managed by a single asset manager). Failing receipt of such proof within a month from request NotiFide will be entitled to treat such entities as being separate from the Group and to retroactively apply the normal rate mentioned in 1 of this Section 1 of these Special Conditions.

Subject to the above, where more than one company belongs to the same Group, the following rate scale will apply on a yearly basis, applied to each entity according to chronological arrival on the <u>www.NotiFide.com</u> website:

- For one company or the first one in a Group: EUR 3.000 (+ tax) or EUR 1.000 (+ tax) as described in 1 above, it being specified that this entity's staff number will be deemed equal to the staff number for the Group entity that employs the highest number of staff;

- From the 2nd to the 5th entity:
 From the 6th entity:
- 500 EUR f(+ tax) or each of these additional entities; 300 EUR (+ tax) for each of these additional entities.

The rates mentioned above will be adjusted to reflect changes in the SYNTEC index (published by the Syntec Federation on http://www.syntec.fr), (having a March 2012 level of 239,4), according to the following formula:

P1 = (P0 x S1)/S0, where:

- P0 is the initial price / last price;
- P1 is the new price to be billed;
- S1 is the last SYNTEC index published on or before each anniversary date;
- S0 is the SYNTEC index level as of March 2012 / the SYNTEC index level used for the last price review
